## **PRESS RELEASE** **Press Release No. 2011-008**

The Supreme Court of the Virgin Islands wishes to advise the general public and members of the Virgin Islands Bar of the launching of the Virgin Islands Supreme Court Electronic Filing System ("VISCEFS") pursuant to the proposed Rules of the Supreme Court.

In accordance with the proposed Rules, effective November 2, 2011, all papers required or permitted to be filed in the Supreme Court of the Virgin Islands shall be conventionally or electronically filed with the Clerk of the Supreme Court in accordance with Rules 15(f) and 40.3 utilizing VISCEFS. Therefore, to facilitate the mandatory use of the VISCEFS, the Court has established the following training schedule for both *pro se* litigants and members of the Virgin Islands Bar on both islands:
